

Information of use:

The delivery will be made, at the Hotel, the day after the arrival between 09:00AM and 11:00AM.

Returns before 20:00 on the day of departure.

Rental vehicle conditions.

• FOR THE COLLECTION OF THE CAR IT IS **ESSENTIAL** TO PRESENT A VALID DRIVING LICENCE AND A CREDIT CARD.

Minimum age: 21 years and 2 years of experience.

Additional driver: The fee to include an additional driver is € 3 / day, up to a maximum of € 60.

Franchise and insurance: The loss, robbery or damages caused to goods or objects transported in the vehicle are excluded from basic insurance. The price includes VAT, all-risk insurance with € 700 + VAT franchise, unlimited mileage, port charges, local taxes and fees.

The FRANCHISE and the exemption from the payment of the franchise (SUPER CDW: Insurance that covers the damage of the rented car) Not included, negligence generated by inadequate driving, loss of keys or damaged, tires or wheel breaks.

Fines: They are in charge of the hirer.

General rental conditions

The hirer receives the vehicle in perfect working order, which proves at the moment of taking charge of it; recognizing to be informed of the type of load that the vehicle requires; and committing to return said vehicle in the same conditions in which it receives it. The hirer undertakes to pay all penalties for non-compliance with the rules of circulation and to notify the lessor at the time of liquidation.

The hirer will be responsible, both civilly and criminally, for any liability that may arise from the use of the rented vehicle and no concept will be able to engage in the transportation of merchandise, especially if it is an illegal course.

- Regarding what is established in the previous article is the insured tenant of civil liability towards third parties through an insurance policy arranged with the lessor by the Insurance Company, and the damage to persons under the measures and conditions established in the Mandatory Insurance Regulations.
- The hirer undertakes to take with him the document issued by this company, to exhibit it if required by the Authority to a person of this Company.
- The leasing company reserves the right not to rent the vehicles if it deems it convenient. Likewise, the leasing company may withdraw the leased vehicle if the lessee misuses it or if the

vehicle is driven in an inferior condition of physical conditions motivated by alcohol, drugs, fatigue or illness.

- In no case will be allowed to sublet or drive the rented vehicle to people other than the client contracting, unless express consent of the lessor.
- In any case the exemption of franchise does not include, the loss or break of the keys or remote controls (value according to model between 180 € - 260 €), damage to the wheels and glass of the rented vehicle. If the customer left keys inside the locked car locked, you will be charged € 15 for carrying the double keys. In the event of an accident, the company will replace the damaged vehicle as long as the rental conditions have not been violated.

ELECTRICAL ADDITIONALS

You must deliver a card to be able to use the different loading points that the island has, it is always recommended and as far as possible make use of them and once delivered the vehicle also **return the card delivered.**
